## The subject matter of the contract

The subject matter of the contract is choosing the supplier of set cryorefrigerator and compressor. All elements of the set must be fully compatible with each other.







# Requirements for implementation:

The offer should include maintenance spare part for the set after 10000 hours work and specification of the offered set.

## The set should have:

- Performance 100W @ 80K (+/- 5 W) when working on 50 Hz electric supply
- Circular cold tip at diameter from 57 [mm] to 70 [mm]
- Pair of HP/LP flexible helium hose minimum 3 m length
- Spacing of mounting holes 146 mm every 90 degrees (+/- 1 mm)
- Mounting holes for the M6 screw
- RS232/485 interface for remote control and diagnostic

### Warranty and delivery terms:

The set shall be covered by operation warranty on all parts and workmanship by the manufacturer in the period of at least two years or 5000 hours work (whichever comes first). The Supplier should provide the Customer with free telephone technical assistance during the warranty period.

#### Access criteria:

Minimum 2 references from the last 3 years confirming the delivery of a set with parameters similar to the subject of the inquiry.

Maximum number of points to win: 100 points

P exam. – the net value of the order of the assessed proposal

Note: 1 % = 1 point

Maximum number of points: 100 points

The price must provide for all requirements of this request for proposal and must include all the costs connected with timely and correct execution of the subject matter of the contract and terms and guidelines presented by the Employer, referring to the subject matter of the contract.

## **IX. Exclusions**

Entities with interpersonal links and related by shares with the Employer are excluded from the procedure.

Relations by shares or interpersonal links are understood as interconnectedness between a beneficiary or persons authorized to incur liabilities on behalf of a beneficiary or persons carrying out on behalf of







a beneficiary activities connected with running the procedure of choosing the contractor and the contractor, consisting in, particularly:

- a) participation in the company as a partner of a civil or limited partnership;
- b) possessing at least 10% of shares, unless a lower threshold is not legally defined or has not been defined by the Managing Institute in the programme guidelines,
- c) acting as a member of the supervisory or management board, proxy, plenipotentiary;
- d) remaining in a marriage relationship, in a family relationship or affinity in a straight line, relationship or affinity in the collateral line to the second degree, or in a relationship of adoption, guardianship or custody.
